However, they are still educators/teachers this is involved in management in field studentship, based on the results of interviews with the head school. So, researchers offer the involvement of students and teachers in educational management. This research aims to find out how student management is implemented at SMP Negeri 1 Tondano. This research method is quantitative research, meaning research that focuses on or produces numbers (descriptive data) with a sample of 37 people. The results of this research show that the results of inferential statistical analysis regarding the influence of student management on student learning achievement at SMP Negeri 1 Tondano show that the results of a simple regression test show the influence of student management as seen from the results of the assessment of 37 respondents on student learning achievement which has T = -1.211 with a significance value of 0.234 > 0.05, which means that H 0 is accepted and H 1 is rejected or there is no influence of student management on student learning achievement at SMP Negeri 1 Tondano.

### INTRODUCTION

To achieve educational goals, one of the efforts is through student management. Student management is an arrangement or arrangement of all activities related to students, starting from the entry of students to the exit of students from an institution (Soetopo & Soearto, 1982: 98). Management is an integral component and cannot be separated from the overall educational process. The reason is that without management educational goals can't be realized optimally, effectively, and efficiently, in this context there is growing awareness of the importance of School-Based Management (SBM) (Mulyasa, 2003). Meanwhile, Mulyono (2008), in administrative management and educational organizations, stated that student management is the entire process of activities that are planned and carried out deliberately as well as continuous guidance for all students (in the educational institution concerned) so that they can follow the PBM process smoothly, effective and efficient. Student management also means the entire process of activities that are planned and carried out deliberately as well as continuous development towards all learners so that can follow the process Study teach effectively and efficiently, starting from the acceptance of students until the exit of students from a school (Gunawan, 1996). It is known that organizational skills must be possessed by every student. For this reason, students need to be equipped with organizational skills, because the task of students at school is not only learning, apart from that, students are also required to apply their knowledge in the community to teach and guide the community (Yappi, 2008).

Management aims to carry out a group of administrative activities so that they run according to patterns and plans made together (Burhanuddin, 1994: 15). Because student management is one of the substances of educational management. Student management occupies a strategic and central position in educational services, both within the school institutional setting and outside the school institutional setting (Minarti, 2011: 155; Rahman, 2021).

In student development, programs and activities directly involve students as the target. The final target of student development is optimal student development following the students' personal characteristics, developmental tasks, needs, talents, interests, and creativity. Meanwhile, on the one hand, achievement is the result that has been achieved from what is done (Preparation Team, 1997: 787). So, learning achievement is a result achieved by students during the teaching and learning process within a certain period. In general, learning achievement in school takes the form of giving grades from teachers to students as an indication of the extent to which students have mastered the subject matter that has been presented. The result of learning activities is a change in an individual, otherwise if no change occurs within the individual, learning is said to be no success. Learning achievement is the result obtained in the form of impressions that result in changes in the individual as a result of learning activities (Djamarah, 2002). Learning achievement is a reflection of the mastery of students' abilities as determined for a particular lesson because every effort made in learning activities by both teachers as teachers and students as learners aims to achieve the highest possible achievement.

Based on initial observations, which directly communicated with the deputy principal for student affairs, the implementation of student management at SMP Negeri 1 Tondano had been carried out as it should be following the basic principles of student management such as Planning that was running well in accepting new students, educators/teachers at SMP Negeri 1 Tondano are not involved in the selection. However, these educators/teachers are still involved in management in the field of student affairs. Furthermore, from the aspect of developing students in extracurricular activities such as OSN (Science Olympiad), O2SN (National Student Sports Olympiad) Scouting, and PMR. All activities at school are ultimately aimed at helping students develop themselves. This effort will be perfect if the students themselves actively try to develop themselves following the programs carried out by the school. Therefore, it is very important to create and understand conditions and situations so that students can develop themselves perfectly. This means that quality student management is needed for the school. So that students can grow and develop according to the student's physical, intellectual, social, emotional, and psychological potential. All developments will reflect the quality of the students themselves in the educational process at school.

Relevant research on student management and learning achievement has been studied from various points of view. These include discussing aspects of student management and learning discipline (Firmanto, 2017), student management and visionary leadership (Fauzan, 2016), basic concepts of student management (Ariska, 2015; Santriati, 2019; Aliyyah, et.al., 2019), and the relationship between student management and students' learning outcomes and non-academic achievements (Amin, et.al., 2018; Putri, et.al., 2021; Suprapto, 2017). Table 3, shows the results of frequency distribution calculations, it is known that 37 respondents (91.89%) chose learning achievement in the medium category. And there were 3 respondents (8.1%) who chose learning achievement in the high category. Meanwhile, if you look at the average value of 79.70 obtained, if put in two categories, is at intervals 77 - 82 in the low category so it can be concluded that student management is in a low category.

Responding to the low level of student management and its influence on student learning achievement, Sugini (2011) explained that student management should be carried out by competent teachers in their fields, one indicator of which can be seen from the teacher's academic qualifications. Furthermore, Aisah (2015) explained that student management is often not directly proportional to the level of student satisfaction with academic services and school administration services. For this reason, efforts are needed to improve the learning culture and conducive organizational climate in schools or madrasas to improve learning achievement and an effective student affairs program governance system (Putri, 2020; Nur, 2021; Nisak, 2019; Jannah, et.al., 2019).

Based on the description above, it is understood that the management of student programs at madrasas or schools is urgent. This is because recognition of the quality of educational institutions cannot be separated from the quality of graduates, namely students as potential alumni of the institution. Therefore, student management should be improved by the school. The main goal is to

provide maximum (optimal) academic and administrative services for children's growth and development.

# Management Influence Education To Performance Study Learners in Tondano 1 Public Middle School

Based on inferential statistical data analysis techniques which were carried out to determine the extent of the influence of educational management on student learning achievement at SMP Negeri 1 Tondano. Found the calculated T value =-1.211 with a significance value 0.234 > 0.05 H0 is accepted And H1 is rejected, the condition is that if T calculated is smaller than Ttable, then H0 is accepted and H1 is rejected and vice versa if T calculated is greater than Ttable, then H 0 is rejected and H 1 is accepted. That means there is no influence real (significant) relationship between educational management and student learning achievement at SMP Negeri 1 Tondano.

The results of this research follow the opinion of Rohana (2015), who said that student management also means the entire process of activities that are planned and carried out deliberately as well as continuous guidance for students so that they can participate in the learning process effectively and efficiently, through from reception participant educate until to out participant educate from something school. The effectiveness of student management can be seen from its objectives and functions, First, student management has the general objective of organizing various activities in the student affairs sector so that learning activities in schools can run smoothly, in an orderly, orderly manner, and achieve school educational goals. Second, student management functions as a vehicle for students to develop themselves as optimally as possible, both concerning aspects of their individuality, social aspects, aspirations, needs, and other potential aspects of students.

However, student management has not been able to improve student learning achievement. The learning achievements of students at SMP Negeri 1 Tondano can increase if the current student management is updated, both in selection, coaching and even when students leave (graduate) so that the processes experienced by students can become something that will increase student learning achievement. According to Paudi, et.al. (2015), student management is aimed at developing and strengthening human resources in madrasas (schools). In line with this, Arnal, et.al. (2020) explain that student management can help improve organizational quality. The excellence that must be maintained in student management in madrasas is the Islamic character values inherent in students' personalities (Cahyani, 2020; Karimah, 2021; Febriyani, 2020).

Looking at the description, it is understood that student management affects participants' learning achievements students at SMP Negeri 1 Tondano have not shown any significant influence (results). Therefore, careful planning is needed in proposing student affairs activity programs to increase students' interest and develop their talents. The main goal is to produce superior human resources (HR), both academic and non-academic, in a systematic (managed) and effective manner.

#### CONCLUSION

Based on the explanation above, it can be concluded that the results of the inferential statistical analysis regarding the influence of student management on the learning achievement of students at SMP Negeri 1 Tondano show that the results of a simple regression test show the influence of student management as seen from the results of the assessment of 37 respondents on the learning achievement of students
